# Regulation of the Council of Ministers dated 31 October 2018 on the thresholds for considering an incident as major<sup>1)</sup>

Pursuant to Article 11 of the Act of 4 July 5 on the National Cyber Security System (Journal of Laws item 1560), the following is decreed:

- § 1 The thresholds for recognising an incident as major according to the type of incident in individual sectors and subsectors specified in Annex 1 to the Act of 5 July 2018 on the National Cyber Security System are set out in the Annex to the Regulation.
  - § 2 The Regulation shall enter into force on the day following the day of its publication.

This Regulation implements within its scope Directive 2016/1148 of the European Parliament and of the Council of 6 July 2016 on measures for a high common level of security of networks and information systems within the Union (OJ EU L 194 of 19/07/2016, p. 1).
